**HB1258** - Prohibit political subdivisions from restricting firearms- Preamble ¶ 1, 2, Plank 6.4 indicate **For (Failed)**

**SB38** - \$400K Renovation & transfer of GF&P bldg to Ag- Preamble ¶ 5, 6, Plank 5.2, 5.3 indicate **Against** (Passed)

**SB 45** - \$450K Replace Ag storage facility- Preamble ¶ 5, 6, Plank 5.2, 5.3 indicate **Against** (Passed)

**SB46** - \$1 Million SDSU to build bldg on leased ground- Preamble ¶ 5, 6, Plank 5.2, 5.3 indicate **Against** (Passed)

**SB27** - Increase fines and punishments Cosmetology Commissions can assess- Preamble ¶ 3, 4, 6 Plank 6.1 indicate **Against (Failed)**
